This privacy and security policy ("this policy") outlines DrugLegends Network(s) practices and commitment to the customer in this regard.

By visiting this Platforms and communicating electronically with us, you consent to the processing and transfer of your personal information as set out in this Privacy Statement.

DrugLegends Network reserves the right, at its sole discretion, to modify or replace any part of this Agreement. It is your responsibility to check this Agreement periodically for changes. Your continued use of or access to the Site following the posting of any changes to this Agreement constitutes acceptance of those changes. DrugLegends Network may also, in the future, offer new services and/or features through the Site (including, the release of new tools and resources). Such new features and/or services shall be subject to this *Agreement*.

1. Why the Privacy Policy?

- a. We are committed to the privacy and confidentiality of information provided to us. This Privacy Statement provides information to help you understand how we collect, use and share your personal information and our privacy practices with regard to any personal information collected by us from you directly and/or through the Platforms or the use of our products and services.
- b. Personal information means information which identifies you, and includes information such as your name, email address, telephone number, and password, as well as any other personal data collected.

2. How and when we collect information.

- a. We constantly collect information when you register and account and provide services or purchase services like.
 - i. Buy a product or service from us (Account upgrades)
 - ii. Register on the platforms as a member.
 - iii. Participate in competitions
 - iv. Browsing our platforms/affiliated platforms.
 - v. Using and interacting with our discord bot.
- b. What we collect.
 - i. Your contact with us (Emails etc)
 - ii. Your account information (Registering with our platforms services)
 - iii. Paypal Email
 - iv. Payment gateways

3. Sharing your personal information.

- a. DrugLegends Network will never share any personal information with any third-party organizations.
- b. DrugLegends Network will ensure your private information is regulated by our team and protected with the highest-grade information security on the market.
- c. DrugLegends Network utilize personal/company owns software and hardware, your information is not stored on any 3rd party providers and will be regulated by our own team.
- d. DrugLegends Network, management, employees has undisclosed access to relevant personal information in order to solve grievances and operate to the best of our abilities.
- e. We'll never ask for your secure personal or account information by unsolicited means of communication. You're responsible for keeping your personal and account information secure and not sharing it with others.
- f. You may choose to disclose your information in certain ways such as social plug-ins (including those offered by Google, Facebook, Twitter and Pinterest) or using third-party services that allow you to post reviews or other information publicly, and a third party could use that information.
- g. Social plug-ins and social applications are operated by the social network themselves and are subject to their own terms of use and privacy and cookies policies. You should make sure you're familiar with these.

4. Removal of personal information.

- a. Under the law, you have the right to access, correct, amend, delete your personal information or to object to the processing of your personal information. Upon receipt of your written request and enough information to permit us to identify your personal information, we will disclose to you the personal information we hold about you, for which we may make a charge as allowed by applicable law.
- b. We will also correct, amend or delete any personal information that you tell us is inaccurate and notify any third-party recipients of the necessary changes. You may update any information you have given to us by contacting us at our registered address. Requests to delete personal information are subject to any applicable legal and ethical reporting or document retention obligations imposed on us.
- c. Once your account is deleted information cannot be retrieved.

5. **Your consent**

- a. We process your personal data if you have consented to the processing activity. You may revoke your consent at any time. Doing so will bar us from further processing of your personal data based on your consent but will not impact the lawfulness of processing based on your consent before it was withdrawn. Some of the features of our products and services might be only available based on consent.
- b. Revoking access to process your relevant data will result in your account being terminated.
- c. Terminated accounts information are deleted. (Section 4.c)
- d. Suspension of accounts does not regulate the termination of account data collection.
- e. If we decide to sell, buy, merge or otherwise reorganize our businesses in certain countries, this may involve us disclosing personal data to prospective or actual purchasers and their advisers, or receiving personal data from sellers and their advisers
